# Installing the Side Card

## **ESD Precautions**

It is recommended that you fit and check a suitable anti-static wrist or ankle strap and observe all conventional ESD precautions when handling plugin modules and components. Avoid contact with backplane components and module connectors, etc.

## Opening the drawer

This topic describes the procedure of opening the drawer to replace the side card.

Check that the replacement has the correct part number and part (ie LH replacing a LH sideplane). The front panel LEDs on the enclosure drawer identify the failed side plane. See the following figure.





Figure 1. Front panel - drawer status indicators

**Important:** To avoid HDDs from overheating while the enclosure is powered, the hotswap operation must be undertaken in a maximum ambient temperature of 30°C and within a 10-minute period.

1. Ensure that the anti-tamper locks are not engaged. The red arrows on the locks point inwards if the locks are disengaged as in the following figure. Unlock them if necessary by rotating them counterclockwise using a screwdriver with a torx T20 bit.




Figure 3. Open drawer

- 2. Push the drawer latches inward and hold them (see Figure 3).
- 3. Pull the drawer all the way out until it locks open.

## **Removing the Side Card**

This topic describes the procedure of opening the failed side card.

1. Fully loosen both captive screws at each end of the top cover, unclip from lower cover, and remove as per the following figure.




Figure 4. Removing the top cover

2. Wait for the green '12V Power' LED to go out and the yellow 'Power Disabled' LED to be lit. See the following figures.




Figure 5. Lower cover and card




Figure 6. Components

- 3. Unclip the three power cables, allowing the cables to hang down at the rear of the drawer.
- 4. Unclip the SAS connectors at the rear of the side card.
- 5. Loosen the three captive screws fully, retaining the lower cover.
- 6. Use the removal tool (included in this FRU kit) to lever the side card from the drawer at highlighted locations. See the following figure.




Figure 7. Removing lower cover and card

# Replacing the Side Card

This topic describes the procedure of fixing the new side card.

1. Locate the side card assembly in position over the mating half connectors and apply pressure on the pressure application points until the connectors are fully mated.




Figure 8. Replacing lower cover and card

- 2. Connect the SAS connectors on the side card (observing the connector keying)
- 3. Tighten the three captive screws fully.
- 4. Attach the power cables.

**Important:** To avoid excessive tension on the cables and that the covers sit correctly, see the cabling positions.

- 5. Position the rear tab of the top cover into the slot on the lower cover.
- 6. Rotate the top cover down, fitting each of the three tabs into the corresponding slots on the lower cover. See the following figure.




Figure 9. Replacing the top cover

- 7. Fasten the front mounting screw on the top cover first. Finally, fasten rear screw fully.
- 8. Wait for the yellow 'Power Disabled' LED to go out and the green '12V Power' LED to be lit.

## Closing the drawer

This topic describes the procedure of closing the drawer after the side card is replaced.

- 1. Press and hold both of the black latches on the sides of the drawer.
- 2. Push the drawer in slightly.
- 3. Release the latches.
- 4. Push the drawer all the way back into the enclosure, ensuring that the drawer clicks home.

After you close the drawer, complete the following steps to ensure that the installation is successful.

- 1. Check the sideplane LEDs on the front panel. The green Power LED must be illuminated and amber LEDs must not be illuminated.
- 2. Update the sideplane firmware elements to match the versions in the remainder of the enclosure.
