Welcome to the February 2014 fix pack release of IBM® TRIRIGA® Application Platform 3.3.2.1. This fix pack requires that your IBM TRIRIGA Application Platform version be 3.3.2 before this fix pack is applied. This fix pack only patches the changes that are described in "[IBM TRIRIGA Application Platform 3.3.2.1 Changes](#)" to your existing platform implementation.

## IBM TRIRIGA Application Platform 3.3.2.1 Changes

You upgrade your version of IBM TRIRIGA Application Platform for the 3.3.2.1 release by fix pack. You must be on IBM TRIRIGA Application Platform version 3.3.2 before you apply this fix pack.

To download the 3.3.2.1 fix pack, go to Fix Central at the following link: <http://www.ibm.com/support/fixcentral>. In the Find product tab, select **IBM TRIRIGA Application Platform, 3.3.2**, choose your platform, and continue. Select **Browse for fixes** and continue. Download the 3.3.2-TIV-TAP-FP001-README readme file and the 3.3.2-TIV-TAP-FP001 package. Follow the directions in the readme file.

Document Management	A unique constraint error no longer occurs when you double-clicked the Check In action in Document Manager. (Tri-119499)
Globalization	Resolved an issue with currency formatting when the default language is set to anything other than US English. (Tri-120860)
Installation	Resolved an issue that caused metric reports to not render on WebLogic 11. (Tri-117910)
Integration Object	A proxy no longer causes a time out error during the geocoding process. (Tri-119495-IV53465)
Integration Object	Now error instance records are only generated for the specific data related to the actual record that failed. (Tri-119497-IV52941)
Reporting	GIS maps now return associated records that use a Record ID context filter. (Tri-119496-IV53755)

Reporting	Number fields are now formatted correctly in Microsoft Excel when you export Microsoft Excel files from TRIRIGA reports. (Tri-119959)

Reporting	Resolved an issue where exported values were not exported with translated values when users with a default language other than US English exported a report with a classification field. (Tri-118294)
Reporting	Resolved an issue where some SAP Crystal Reports did not render and required a clientSDKOptions.xml file with the VerifyDatabaseOnSetDataSource property set to false. (Tri-115987)
Reporting	Using the Created Date or Modified Date fields as filters in TRIRIGA reports no longer results in a stack trace. (Tri-120595)
Security	An Upload File action no longer shows a white screen and prevents the upload when the protocol is secure. (Tri-119498-IV52146)
Security	The Upload File action now switches to the multi-file option when the protocol is secure (https). (Tri-117775)
Security	You no longer need to enter your SSO credentials a second time when you open a task inside a Gantt section. (Tri-115850-IV52377)
