You can find the short name for a directory by running this command: dir/x.

#### Installing on IBM Content Collector server

- 1. Stop the IBM Content Collector Web Application Liberty and IBM Content Collector Documentation services.
- 2. Back up the key.p12 certificate store used for the Liberty Web Application present at below location:
  - <ICC\_installation\_directory>\AFUWeb\wlp\usr\servers\AFUWeb\resources\security
- 3. Uninstall the Liberty Web Application by running the following program:
  - <ICC\_installation\_directory>\AFUWeb\afu\_ewas\_uninstall.bat
- 4. Uninstall the Documentation application by running the following program:
  - <ICC\_installation\_directory>\AFUWeb\afu\_help\_uninstall.bat
- 5. Backup the following directories to a temporary folder and then delete them from original locations:
  - <ICC\_installation\_directory>\AFUWeb\wlp

- 6. Extract wlp.zip from the temporary directory to the following directory:
  - <ICC installation directory>\AFUWeb
- 7. Run the following commands to install the IBM Content Collector Web Application:
  - <ICC\_installation\_directory>\AFUWeb\afu\_ewas\_install.bat
  - <ICC\_installation\_directory>\AFUWeb\afu\_help\_install.bat
- 8. Start the services that you stopped in step 1.
- 9. Start the Configuration Manager.
- 10. Go to **General Settings** > **Configuration WebService** and performany of the following:
  - a. Click **Reconfigure**, or
  - b. Change the **Description** and save the settings to trigger reconfiguration of the JDBC connection.
- 11. You can use the following command to confirm the upgrade:
  - <ICC\_installation\_directory>\AFUWeb\wlp\bin\productInfo version—ifixes

The version of Liberty Web Application should be 21.0.0.4.

#### **Uninstalling from IBM Content Collector server**

- 1. Stop the IBM Content Collector Web Application Liberty and IBM Content Collector Documentation services.
- 2. Back up the key.p12 certificate store used for the Liberty Web Application present at the following location:
  - <ICC\_installation\_directory>\AFUWeb\wlp\usr\servers\AFUWeb\resources\security
- 3. Uninstall the Liberty Web Application by running the following program:
  - <ICC installation directory>\AFUWeb\afu ewas uninstall.bat
- 4. Uninstall the Documentation application by running the following program:
  - <ICC installation directory>\AFUWeb\afu help uninstall.bat
- 5. Restore the original folder of Liberty Web Application Profile backed up in step 2 of <u>Installation</u>.
  - <ICC\_installation\_directory> $\AFUWeb\wlp$
- 6. Run the following commands to install the IBM Content Collector Web Application:
  - <ICC installation directory>\AFUWeb\afu ewas install.bat
  - <ICC\_installation\_directory>\AFUWeb\afu\_help\_install.bat
- 7. Start the services that you stopped in step 1.
- 8. Start the Configuration Manager.
- 9. Go to **General Settings** > **Configuration WebService** and performany of the following:
  - a. Click **Reconfigure**, or
  - b. Change the **Description** and save the settings to trigger reconfiguration of the JDBC connection.
- 10. You can use the following command to confirm the removal:
