- 1. The server package of Content Collector 4.0.1 fix pack 14 (4.0.1.14) is required.
- 2. For upgrading afuinfocenter.ear: Any fix pack of Content Collector 4.0.1 from 10 (4.0.1.10) to 14 (4.0.1.14).
- 3. For upgrading **afu\_web.ear** and **docViewer.ear**: Server package of Content Collector 4.0.1 fix pack 14 (4.0.1.14).

Notes:

- When following the instructions, replace <*ICC\_installation\_directory*> with the name of your Content Collector installation directory.
- If the installation directory path contains space, you must use Windows short names while navigating. For example:

**Directory path with spaces**: C:\Program Files (x86)\IBM\ContentCollector should be written as

**Desired path**: *c*:\*progra~2*\*IBM*\*ContentCollector*.

You can find the short name for a directory by running this command: dir/x.

## Installing this fix

- 1. Stop the following services:
  - a. IBM Content Collector Web Application Liberty
  - b. IBM Content Collector Documentation Liberty
- 2. Extract the contents of the 4.0.1.14-IBM-ICC-Server-IF002.zip file that you downloaded from the Fix Central to a temporary folder. The contents of the compressed file are:
  - a. afuinfoCenter.ear
  - b. afu\_web.ear
  - c. docViewer.ear
- 3. Go to the following location and delete the folder named workarea:
  - a. <ICC\_installation\_directory>\AFUWeb\wlp\usr\servers\AFUInfoCenter
  - b. <ICC\_installation\_directory>\AFUWeb\wlp\usr\servers\AFUWeb
- 4. Take a backup and then delete the **ant-apache-log4j.jar** and **ant-apache-log4j.pom** files as per the following:
  - a. Backup from: <ICC\_installation\_directory>\AFUWeb\ant\lib
  - b. Delete the files from the original location.
- 5. Take a backup of the **afuinfoCenter.ear**, **afu\_web.ear** and **docViewer.ear** files from the following location: <*ICC\_installation\_directory*>\AFUWeb
- 6. Copy the afuinfoCenter.ear, afu\_web.ear and docViewer.ear files from Step 2.
  - a. Paste them in the following folder: <ICC\_installation\_directory>\AFUWeb
  - b. Run the following batch files:
    - i. afu\_ewas\_undeploy.bat
    - ii. afu\_ewas\_deploy.bat
- In Configuration Manager, click Reconfigure under Configuration Web Service in the General Settings menu. Check that the IBM Content Collector Web Application Liberty service is started after the reconfiguration process

is complete.

8. Start the IBM Content Collector Documentation Liberty service.

## Uninstalling this fix

- 1. Stop the following services:
  - a. IBM Content Collector Web Application Liberty
  - b. IBM Content Collector Documentation Liberty
- 2. Go to the following location and delete the **afuinfoCenter.ear**, **afu\_web.ear** and **docViewer.ear** files: <*ICC\_installation\_directory*>\AFUWeb
- 3. Copy the **ant-apache-log4j.jar** and **ant-apache-log4j.pom** files that you backed up in Step 4 of 'Installing this fix'.
  - a. Paste it in the following folder:  $<ICC\_installation\_directory> \AFUWeb\ant\lib$

- 4. Copy the **afuinfoCenter.ear**, **afu\_web.ear** and **docViewer.ear** files that you backed up in Step 6 of 'Installing this fix'.
  - a. Paste it in the following folder: <ICC\_installation\_directory>\AFUWeb
  - b. Run the following batch files:
    - i. afu\_ewas\_undeploy.bat
    - ii. afu\_ewas\_deploy.bat
- In Configuration Manager, click Reconfigure under Configuration Web Service in the General Settings menu. Check that the IBM Content Collector Web Application Liberty service is started after the reconfiguration process is complete.
- 6. Start the IBM Content Collector Documentation Liberty service.

## **Fixes and changes**

This interim fix upgrades all the Log4j related JAR files that are used by Content Collector to the latest versions.
