Installation information

Steps to install this fix:

1. Extract the file 4.0.1.8-IBM-ICC-Server-IF003.zip to a temporary directory.

2. Stop the IBM Content Collector Task Routing Engine Service and IBM Content Collector Web Application service.

- 3. Run the Interim Fix installer (4.0.1.8-IBM-ICC-Server-IF003.exe).
- 4. Following files should be updated/added after the successful installation

Files updated:

a. afu-expirationmgr.jar - (<ICC Installation Folder>\tools\ExpirationManager\)

- b. afu-P8ExpirationMgr-config-sample.properties (<ICC Installation Folder>\tools\ExpirationManager\)
- c. **afu-CM8ExpirationMgr-config-sample.properties** (<ICC Installation Folder>\tools\ExpirationManager\) Files added:
- a. ICC_ReplicaID_Generation_Tool.nsf (<ICC Installation Folder>\tools\ExpirationManager\Notes_addon)
- b. Selected_Users.txt (<ICC Installation Folder>\tools\ExpirationManager\Notes_addon)
- 5. Start the IBM Content Collector Task Routing Engine Service and IBM Content Collector Web Application service.

Removing the Interim Fix:

- 1. Stop the IBM Content Collector Task Routing Engine Service and IBM Content Collector Web Application service.
- 2. Go to the following folder in installation directory and run the rollback.cmd file:

Expiration Manager User Deletion:

The expiration manager tool now supports the deletion of archived emails of a particular user when the employee leaves an organization/community. Also, in European General Data Protection Rule (GDPR), every EU citizen can request that their personal information must be deleted, which is now taken care by the tool. The user-related email deletion must be an extension of the expiration manager, to leverage existing plausibility and consistency checks.
